Public safety continues to be at the forefront of national conversations, and UCI has taken many critical steps towards improving safety and security on campus. Two major initiatives took place this year: an external review of the UCI Police Department overseen by PSAC and the systemwide UC Community Safety Plan.

The review of the UCI Police Department conducted by Mike Davis of MBD Innovation began in the fall of 2020 and was completed in early 2021. The review culminated in a report and recommendations to move forward in structural, cultural, and systemic change. The full report, Recommendations for the Transformation of Public Safety in the UCI Community, can be viewed at psac.uci.edu.

The UC Community Safety Plan is a systemwide effort to reimagine our approach to campus safety and security that received extensive input from UC students, faculty, staff, and alumni. PSAC Chair and Professor Katie Tinto served as UCI's representative in developing the plan, and implementation of four guidelines and corresponding 31 actions is currently underway. PSAC continued working diligently to ensure their great work during the pandemic. Website enhancements increased transparency, and "I am PSAC" was added to showcase members' reasoning for service on the committee. ## Message from PSAC Chair

In the wake of the national protests calling for racial justice and an end to police violence in May 2020, on June 9, 2020, Vice Chancellors Douglas Haynes and Ronald Cortez and Chief Liz Griffin asked the Public Safety Advisory Committee (PSAC) to conduct an evaluation of the UCI Police Department. In the fall of 2020, PSAC led an honest, in-depth assessment of the UCI Police Department and its role and effectiveness in serving all segments of the university community. PSAC delivered its report in February 2021, recommending specific changes to policing on campus as well as a broader introspection about the goals and meaning of public safety in our community. Following this report, Chancellor Gillman appointed Vice Chancellor Doug Haynes to implement



PSAC's recommendations for change, a university-wide effort that is currently underway. On a systemwide level at the University of California, the UC Community Safety Plan was announced in Summer 2021, a reflection of the many segments of our community now focused on the important day-to-day work in creating systemic change.

As PSAC states in our February 2021 report, <u>Recommendations for the Transformation of Public Safety in the UCI Community</u>, we are at a point in our history of policing on the UCI campus and nationwide where small tweaks are insufficient. PSAC is committed to structural, cultural, and systemic change. Such change requires broader, longer, and more difficult, introspective work. PSAC also recognizes that the scope of such systemic transformation requires that we move forward in smaller steps in order to accomplish this broader change.

## Background

The Public Safety Advisory Committee (PSAC) was established in February 2018, created thanks to recommendations put forward by then UCI Academic Senate Chair William Parker in June 2017. The Senate Cabinet endorsed recommendations from the report produced by the ad hoc UCIPD-UCI Community Relations Committee convened by the Academic Senate in Fall 2016.

### **Description and Charge**

The Public Safety Advisory Committee proactively seeks the advice and counsel from a diverse group of community members regarding issues that impact the safety and quality of life of students, faculty, staff, and visitors of the UCI campus and Medical Center.

Public Safety Advisory Committee serves as a link between the campus community and the UCI Police Department. PSAC provides a forum to discuss and make recommendations on public policies, community outreach, and may participate on hiring panels for key UCI Police Department personnel. The advisory committee produces an annual report which summarizes its activities and includes key data of interest to the campus community, including the number and types of complaints the UCI Police Department receives.

### **PSAC Membership**

The Public Safety Advisory Committee members represent the diversity of campus stakeholders, including students, faculty and staff of UCI. Members are appointed by the CFO and Vice Chancellor of the Division of Finance and Administration from nominations provided by representative groups. Chief Griffin expressed her appreciation to PSAC for the feedback on the proposed interim recommendations. In response to concerns raised about the Bait Bike Program, UCIPD will research the effectiveness of the program. It will also work to identify other potential locations in the vicinity to book misdemeanors besides the county jail.

CFO and Vice Chancellor Ron Cortez provided an update on the Campus Safety Task Force. Mike Davis is on track with the timeline for the review of UCIPD to be completed in late 2020. He announced that the 2019-20 PSAC Annual Report has been published and can be found on the PSAC website.

Chief Griffin shared that UCIPD began training their officers on the Racial and Identity Profiling Act (RIPA). She announced that two internal officers were promoted to the sergeant position.

Chief Griffin also provided an overview of the October 1st protest and the particular incidents that occurred, one of which resulted in a citizen's arrest. Assistant Vice Chancellor and Chief of Staff Dormitorio and Lieutenant Hallinan were both present at the event and shared their perspectives with PSAC.

Tierney Anderson presented on the Case Management Team (CMT). This group brings together representatives from across the campus with collective experience and knowledge to address issues related to harassment and sexual violence. They work to ensure that reports are responded to consistently, efficiently, and appropriately.

Chief of Staff Mary Clark announced that the new PSAC website has launched. She also provided an update on the review of UCIPD. Mike Davis is on track to finish his work this year and will touch base with the PSAC subcommittee in January 2021 regarding his report and next steps for communicating his findings.

Assistant Chief Cooper shared that UCIPD received approval for a grant to have a K9 on campus after receiving input from PSAC on this proposal at the Fall 2019 quarterly meeting. The goal is to have the K9 and its handler in place by the end of the academic year. He announced that UCIPD's partnership with Orange County Health Care Agency (OCHCA) has been funded. This pilot project allocates an OCHCA clinician to be at UCI on Wednesdays to help respond to mental health-related calls.

PSAC began planning for the Town Hall to be held in 2021. There was discussion of various formats, including a "traveling" Town Hall in hopes of maximizing their reach. Committee members also discussed creating a video to highlight the various mental health/well-being services and resources available to the campus community.

### **UCI Police Department Complaint Data**

Formal complaints result in an investigation, and complainants will be notified of the disposition. The average time it takes to process and investigate a complaint is between three and six months; however, each case is unique. Additional information regarding complaints can be found on the UCI Police Department website: <a href="mailto:police.uci.edu/commendations-complaints">police.uci.edu/commendations-complaints</a>.


#### The possible findings are:

- Unfounded: When the investigation discloses that the alleged act(s) did not occur or did
  not involve Department personnel. Complaints, which are determined to be frivolous, will
  fall within the classification of unfounded.
- **Exonerated**: When the investigation discloses that the alleged act occurred, but that the act was justified, lawful and/or proper.
- **Not Sustained**: When the investigation discloses that, there is insufficient evidence to sustain the complaint or fully exonerate the employee.
- **Sustained**: When the investigation discloses sufficient evidence to establish that the act occurred and that it constituted misconduct.
- **No Finding:** The complainant failed to provide additional information needed to complete the investigation.
- **Complaint Withdrawn:** The complainant affirmatively indicates the desire to withdraw their complaint.
- **Mediation:** By mutual agreement with all involved parties the case was mediated and the complaint withdrawn.
- Referred to Other Entity: The investigation determined that persons other than UC Irvine Police employees were involved or the investigation falls within the jurisdiction of the UCI Office of Equal Opportunity and Diversion (OEOD).
